

CANDIDATE COMMITTEES 2019 FILING REQUIREMENTS

Candidate Committees are required to file the following statements in 2019:

- **2018 Annual Statement** – *due Jan. 31, 2019*
- **Pre- and Post-Election Statements** – *if on a ballot in 2019 for office of committee or spends/receives money for a write-in campaign*
- **Quarterly Statements in July & October** – *if not on a ballot in 2019 for office of committee*
- **Late Contribution Reports**

Carefully review the Candidate Committees 2019 Campaign Finance Filing Schedule on the back of this notice to ensure you are aware of your committee's filing requirements.

Statements are due by 5 p.m. on the filing deadline and can be mailed or delivered to Macomb County Election Dept., 32 Market, Mt. Clemens MI 48043; faxed to (586) 469-6927; or e-mailed to elections@macombgov.org.
